

### Spotlight: Next Steps in Operationalizing Locally-Led Development

In January 2022, Humentum launched a year-long webinar series for prominent global thought leaders to consider what it will take to operationalize locally-led development. We convened more than 2,000 policy makers and practitioners from over 100 countries – donors, international NGOs (INGOs), and national NGOs (NNGOs) alike – to debate what it will take to realize not only USAID’s specific targets, but also a more inclusive and locally-led sector.

From these discussions, and other conversations with our members and stakeholders, [we believe that change will only happen when organizations unlock the strategic power of their operating models](#), and funder policies create an enabling environment for more equitable ways of working.

What do we mean by the strategic power of operating models? At Humentum, we’ve focused on four key components of operations that can foster equitable, resilient, and accountable ways of working. They are:



Humentum believes that power will shift when funders, international, and national organizations focus on these [four components of operations, and what we call the 12 levers of change](#). This belief has driven our advocacy work throughout the past year and will continue to do so in 2023.

We focus our efforts across the sector—with funders, INGOs, and NNGOs—to create a global appetite for operational change. Through the power of this sector-wide network, [we've learned many lessons about what it will take to operationalize locally-led development](#).

Despite differences in positionality, experience, and focus area, one theme rose to the top of our discussions: to make change happen, we must work together to form [partnerships of consequence](#), rather than partnerships of convenience. And, to develop truly equitable partnerships for development, we must rethink our organizations' institutional architecture, our approach to people and culture, funding and financial systems, and risk and compliance practices. These changes won't be easy, but by continuing 'business as usual,' we risk excluding local partners and implementing ineffective and unsustainable programs.

The good news is that change is already happening, and powerful actors are understanding the importance of equitable development. Our 2022 ERA Index and our December Executive Summit, which brought together over 100 executives from across the sector, showed that INGOs are thinking and talking about change and are already implementing changes in areas where they have the most autonomy, in their institutional architectures and people and culture practices. While this is encouraging, we risk snapping back to outdated ways of working if funder policies continue to prohibit transformative change, especially in areas of funding and risk.

This edition of the Advocacy Advisor rounds up the important policy and regulatory updates in each of Humentum's four components of change. ## Emergent Issues

### [The General Services Administration \(GSA\)'s transition to the Uniform Entity Identifier](#)

On April 4, 2022, the federal government transitioned from using the DUNS number to identify entities, replacing it with the Unique Entity Identifier (UEI) created on SAM.gov. GSA claimed that the transition to the UEI would streamline the process of doing business with the federal government. To the contrary, glitches and processing issues have continued to plague the process resulting in a backlog that has reportedly grown to 50,000 applicants. As Cynthia Smith explains in this recent [Federal News Network article](#), the delays have had an outsized impact on new and local foreign partners' ability to do business with the US government.

Thanks to Humentum's advocacy on this issue, USAID issued guidance to its agreement and contracting officers to extend a temporary waiver to the requirement of having a UEI in place prior to administration of funds and commencement of programming [assistance](#) and [acquisition](#) guidance. This is only a temporary reprieve, however, and will not resolve the overarching issues that only the GSA can fix. Humentum will continue to support its members in their efforts to navigate this challenging terrain. ### [Compliance with Section 889 of the National Defense Authorization Act \(NDAA\) FY19](#)

Humentum works with its members to address challenges surrounding compliance with Section 889 of the National Defense Authorization Act (NDAA) FY'19 restrictions on the use of certain prohibited Chinese technologies. Over the past year, we have engaged USAID, USDOS, OMB, and related entities on questions regarding Office of Director of National Intelligence (ODNI) 889 waivers, General Services Administration (GSA) guidance, and the agencies' own due diligence. Both USAID and the [US Department of State have requested and received waivers](#) through 2028 for assistance recipients. In addition, [CDC/PEPFAR recipients are exempted](#) from compliance with the prohibition through the same period, ending September 30, 2028.



## Institutional Architecture

### USAID's Policy Framework

## Funding and Financing

### International Financial Reporting for Nonprofit Organizations (IFR4NPO)

- Humentum has been partnering with [CIPFA](#) on the [IFR4NPO Project](#) to develop International Non-Profit Accounting Guidance (INPAG). Part 1 of the draft guidance was released in November and will be open for comments until 31 March 2023. It covers four key topic areas: (1) Defining Non-Profit organizations, (2) the format of the primary financial statements, (3) the narrative reports that accompany the annual audited accounts, and (4) the concepts and principles that provide a framework for INPAG. ## Risk and Compliance

### USAID's Updated Risk Appetite Statement

- In August, USAID released an [updated Risk Appetite Statement](#) (RAS). First crafted in 2018, the RAS details the Agency's willingness to absorb, share, and/or mitigate the various risks – which have historically ranged from programmatic, reputational, fiduciary to legal, security, and human capital –

related to its strategic objectives. Since these objectives change over time and across administrations, so too must the Agency's RAS.

## US Government Donor Operational Policy and Guidance Updates

### Executive Office of the President

#### National Security Strategy

- In October 2022, the Biden-Harris Administration released its [National Security Strategy](#), outlining the Administration's roadmap for fostering democracy, diplomatic cooperation, and regional security and engagement across the globe. Among its tools of statecraft, the Strategy emphasizes the importance of "[m]aking development assistance more accessible and equitable by increasing engagement with and shifting 25 percent of US Agency for International Development (USAID) funding to local partners, and double USAID's work on empowering women and girls."

### US Agency for International Development

#### FY23 First Quarter New Business Forecast Webinar and Partner Update

- On December 7, USAID/M/OAA hosted the FY23 First Quarter New Business Forecast and Partner Update webinar. A list of responses to questions, as well as a transcript and recording of the webinar, are available on [USAID's Business Forecast page](#), along with FAQs and recordings from prior webinars. During this quarter's meeting, Director Mark Walther provided a recap of recent achievements and an update on the status of the [forthcoming Acquisition and Assistance Strategy "refresh"](#).
- Highlights included: 1) a record number of obligations this last fiscal year, totaling \$35.5 billion going through over 21,000 A&A actions. This was a nearly \$8.7 billion increase from the previous fiscal year, largely due to the war in Ukraine; 2) the results of the Agency's first Partner Experience Survey – which received over 1,400 responses – will be released in the coming weeks; 3) to address the myriad issues with the UEI, USAID developed escalation procedures for urgent registrations, updated guidance for existing exceptions, and provided resources for navigating SAM registration; 4) the final draft of the A&A Strategy refresh is currently with the Office of the Administrator for clearance and public launch early next calendar year. The refreshed strategy will focus on the A&A workforce, streamlining barriers throughout the A&A process, and diversifying the partner community; and 5) OAA is also working on an A&A Strategy Implementation plan, for which they plan to seek community input on award processes and lowering barriers to partnership.
